1. Meeting convened at 7:00 PM

2. Minutes of March 28 meeting were approved

3. Financial Review: Information presented

4. Introduction of members of the Contoocook Lake Area Preservation Association: CLAPA: Carolyn West, Karin Goldstein, Warren Harris, Jim Grier to discuss mission of the association.

Health of the lake was the main topic and its milfoil infestation. Attendance at the meeting was to discuss possibility of funding from Jaffrey ConComm to assist in defraying costs of milfoil eradication. Since Contoocook Lake borders both Jaffrey and Rindge, members of CLAPA would also be meeting with Rindge Conservation Commission to discuss possible funding from that organization. While the association has open membership at dues set at \$55, help is still needed to fund efforts against milfoil.

5. Ongoing Items

A. CPCA: clearing new trails, wetland crossings to consist of boardwalk and small bridges. Trail markers would be placed along pond.

B. Open Space:

1. Tax map showing properties under review in Jaffrey to ask owners to consider open space status.

2. National Heritage Species Week (May 20-26) at Vill Pony Farm. Eighty packets of heritage seed have been put together to hand out during that event. Also discussed invasive species display and endangered species display. Volunteers needed for that event.
