Investment Review

Bryan Sanford, CSRIC (VP, Senior Portfolio Manager) from Bar Harbor Wealth Management presented each trustee member with a printout of the Investment Review. He then preceded to explain the review and answer any questions.

The current economic environment is volatile and will remain so until inflation is under control. The market has been a rollercoaster this year but the JPL portfolio has held up well.

Although the total return from January 2022 - May 2022 is -10.19%, the total return over the last 5 years is +8.10%.

Summary Investment Performance – Twelve Month Period The total earnings have decreased \$15, 275.18 and the total fund performance has decreased 1.43%. Even with these numbers our investments are better than the market overall. Amy Tardiff, CTFA (VP, Wealth Manager) enters the meeting at 10:14 am.

Trustees approve and sign the Investment Policy Statement.
