Marlborough Library Discussion

John Stone, Grace Flesher, and Julie Perrin met with Marlborough library trustees to discuss Marlborough contracting for library services this fall when the Marlborough Library closes for renovations. This would involve Marlborough users obtaining JPL cards. JPL Trustees will discuss as a board and offer Marlborough a price for this.

Since the meeting, Marlborough has contacted Julie to suggest other arrangements. They would like to convert their library to the Apollo system. However, they have no library director nor any trained professional staff. They propose contracting for JPL service (Julie and Bailey) to convert the Marlborough Library to Apollo and estimate that they would need 20% of our professional staff time. Once the conversion has occurred, they would be interested in consortium arrangement with JPL.

This is a large, complicated process and needs the entire JPL board to be involved in these discussions. If the JPL board wants to proceed with this larger idea, a joint meeting of both library boards could take place.
