- Clarify and simplify the planning board process and make sure it is equitable.
- Create an explanatory checklist for applicants who are new to the process.
- Create a welcome packet for people who are new to town addressing where to register a car, get a driver's license, list of utilities, etc. *Perhaps this is something the Chamber could address*.
- Review the Implementation Plan and to see what has been completed and what is still relevant.
- Include a Sustainability Chapter in the Master Plan which would include sections on energy efficiency and renewable sources. M Dillon will write a draft to present to the Board in August.
- Arrange an energy audit for all municipal buildings.
- Address the issue of how to maintain the rural character of the Town, keeping an attractive and vibrant downtown while providing more housing.
- Consider working together with TEAM Jaffrey and the Economic Development Committee to accomplish mutual goals.
- Establish a downtown revitalization advisory committee.
- Address concerns with enforcement of Planning Board decisions. What is the Select Board's responsibility?
- W.W. Cross and St. Patrick School continue to be major issues.
