• Kyle Holombo came before the Board to ask for a change in decision on his abatement denial. He had filed for a building permit in April, was approved in June and consequently paid the water hook-up fee in October. In November, the BOS reduced the rates for water/sewer hookup. He is asking for an abatement for the difference in hookup charges. Chairman Sterling explained that the rates were changed long after he had applied for a building permit and unfortunately, a reversal of their decision wouldn't be possible and Weimann agreed. Mitchell asked if an exception could be made, with Sterling adding that effective dates are firm and the timeline of Mr. Holombo's case happened too late for consideration and didn't want to set a precedence of reconsidering this abatement. After some discussion, Weimann changed his decision. On a motion by Weimann, seconded by Mitchell, the decision to reconsider the previous denial was made (2-1). On a motion by Weimann, seconded by Mitchell, the abatement of \$1,414.00 was approved (2-1).
