- <u>Budget Guidance</u> TM Frederick will be meeting with Department heads in November. He will present the Budget to the Board on December 23,2019. He is asking for direction from the Board. The CPI this year is 2.3%. It was the desire of the Board to start allocating more money for town roads. They would like him to focus on the minimum that needs to be done and put more money into the road budget. If the School budget drops, that would create more road money. Chamberlain asked if the Town should take out a bond to get the repairs done sooner than trying to budget every year. Bonding would have to go to Town Meeting. TM Frederick will have DPW Director Heglin address the Board with his road plan and projected costs. Belletete would like more input from other departments as well.

# **Selectmen's Reports**

<u>Sterling-</u> Meetinghouse Committee had its Fall Inspection. All exit lights were replaced. In 2020 there will be tower repair and painting needed. The quote was for \$25,000. They may look into an LCHIP Grant to fund the project. They may also ask for \$3,000 for their annual warrant article request.

<u>Belletete-</u> School Separation Committee will be sending a formal request to DOE this week to ask for an extension.

<u>Chamberlain-</u> Attended the Annual Cemetery Committee Meeting. They may be asking for \$3,000 for the annual tree warrant article and \$1,000 for the annual gravestone repair article. Conant Cemetery needs repairs of the road conditions etc. which would cost about \$70,000, and planting of maple trees at Cutter Extension would cost \$1,000. They will be looking into donations. ConCom was rescheduled to next week.
