# Marlborough Library Request

The library director of the Frost Free Library in Marlborough

has reached out to Julie to inquire about the possibility of their library patrons temporarily using the Jaffrey Public Library if their library building project goes forward.

After much discussion it was agreed that a general framework should be created for such requests. The framework would help determine a price for such usage based on demographics, number of patrons, and the time frame for the use of our library.

This would be based on the framework that was used to determine the price that the town of Sharon is charged that allows its residents to use our library. The Sharon contract is reevaluated on a yearly basis.

Julie will create this document and bring it to the June Board of Trustees meeting for approval.

#### **Book Bike Donation**

Julie is pursuing the ILMS/ARPA grant through the NH State Library,

which should provide guaranteed funds of \$3,273 which will be used toward the Book Bike purchase. Julie just received a check from the Community Center of Jaffrey to help fund the remaining cost of \$886.

Joe is working on the artwork for the bike and once the artwork is submitted there is a 4 week turn around period until the library receives the bike.

(It should be noted that a town selectman questioned the need for a book bike because he thought the library had a bookmobile. The summer bookmobile, is in fact, run by the local schools and not Jaffrey Public Library. In addition, the bookmobile only visits certain locations and only provides books for children.)

## **Building Update**

Given Masonry should be finishing up their work today. They have successfully replaced two chimneys, repaired bricks, removed gray mortar, repaired and replaced brownstone, re-grouted the arch, and redid the seams.

The roof was repaired by Melanson Roofing.

The exterior locks have been rekeyed (in response to a missing key).

The elevator was not working properly and has been repaired.

## **Internet Policy**

#### **New Business**

#### Conservation Commission MOU Draft

Trustees reviewed and discussed the draft MOU shared by Bill Graff of the Jaffrey Conservation Commission.

Trustees also reviewed NH RSA 202-A:6 which states:

**202-A:6 Library Trustees; Election; Alternates.** – The library trustees shall have the entire custody and management of the public library and of all the property of the town relating thereto, including appropriations held pursuant to RSA 202-A:11, III, but excepting trust funds held by the town. Any town having a public library shall, at a duly warned town meeting, elect a board of library trustees consisting of any odd number of persons which the town may decide to elect. Such trustees shall serve staggered 3-year terms or until their successors are elected and qualified. There may be no more than 3 alternates as provided in RSA 202-A:10.

After reviewing RSA 202-A:6 and considering the motion taken at the last meeting to accept the bushes as a gift from the Jaffrey Conservation Commission, the Trustees amended the draft MOU and will send the amended MOU to the Conservation Commission for review.

#### Warfield Birds

On May 11, 2021, representatives from the Jaffrey Public Library, Jaffrey Civic Center, Jaffrey Center Village Improvement Society, and Jaffrey Historical Society met with Bob Warfield in an effort to support the possible transfer of The Warfield Bird collection from the defunct Sharon Arts Center to somewhere in Jaffrey.

John Stone and Owen Houghton were in attendance and represented the Jaffrey Public Library at this meeting. John and Owen reported on what was discussed at this meeting. Considering display space, storage space, security, and because the legal status of the collection's ownership is in question the Trustees do not feel that the library would be the right place to house the Warfield Birds.
