Julie Perrin, Library Director, announced the Jaffrey Public Library had been awarded a STEAM LEARNING GRANT from MilliporeSigma in the amount of \$20,000 for 2021. The purpose of the grant is to continue our STEAM Learning program, including for kits and if possible, in-person programs for 2021. In addition to general science education, the 2021 focus will be on health literacy. The trustees must vote to approve the receipt of these funds.

There were no questions from the public. Emily Carr shared her appreciation for MilliporeSigma's generosity. Owen Houghton said that MilliporeSigma and the town work together to foster good relationships, and have recently negotiated a long term water contract.
