# **Schedule Public Hearings:**

- 1. Cold Stone Springs supplemental gross appropriation of \$4.3M This amount would cover the over runs due to cost increases. Another 2 grants are being pursued. 90% of the construction plans are done and an RFQ will be going out.
- 2. Stratton Road sewer main replacement appropriation \$1.5M.
- 3. Amend the Stone Arch Bridge TIF District financing plan to create a Capital Reserve Fund for infrastructure improvements and appropriate \$40,000 for said fund.
- 4. Modify the Transfer Station fee schedule as proposed by the Select Board on October 25, 2021.

Fees would start on 2-1-2022. There was discussion of collection of these fees. Presently residents can pay cash to the Town Clerk and bring a receipt with them to the Transfer Station. They can also pay by check at the Station (no cash). If a credit card reader is used, there is a 2.79% fee that is charged. Waiving of the fee will be investigated.

All 4 Public Hearings will be scheduled for the next BOS meeting, January 24, 2022 6:00pm at the Jaffrey Fire Station. They will be noticed in the Ledger, Town website, Town Office and Library.

#### **Municipal Resources Staffing Reports**

<u>Police Department</u> - The BOS reviewed the report and feel that the staffing is at a good level now and no immediate action needs to be taken.

<u>Fire Department</u> - A model would need to be developed with one per diem position added the budget, with the potential for another at a later date. The Chief will need assistance for the integrating the new scheduling from an outside source with experience. There was much discussion, followed by the suggestion of having MRI, who performed the study, assist with the implementing their suggestions.
