On a motion by Sterling, seconded by Weimann, the consent agenda was approved with the exception of Item 2A, which was denied. (3-0).

1. Transfer Station Report and Resolution for Committee Establishment – This will be discussed at the next meeting on 10/30/17.

### **G.** New Business

- 1. <u>Resolution # 2017-35</u> Authorize use of Municipal Building Maintenance Capital Reserve Funds for Police Department oil tank. On a motion by Sterling, seconded by Weimann, Resolution #2017-35 was approved (3-0).
- 2. <u>Resolution #2017-36</u> Acceptance of Grant Funds for NH Division of Historical Resources and Authorize Town Manager to Execute all Documents on the Town's Behalf. On a motion by Sterling, seconded by Weimann, Resolution #2017-36 was approved (3-0)
- 3. Resolution #2017-37 Addition of \$ 5.00 charge for Fire Extinguisher disposal at the Transfer Station. On a motion by Sterling, seconded by Weimann, Resolution #2017-36 was approved (3-0)
- 4. Water and Sewer Connection Fees Presently there is a \$ 2,264 hook up fee for water and sewer. A home in the water/sewer district it's \$4,528 added to the permit fee. The Bos feel this amount is excessive and is a deterrent to building. Sterling stated he would feel more comfortable waiting for actual costs before changing the rates. After discussion, the BOS agreed to the following: On a motion by Sterling, seconded by Weimann, the reduction to \$500 per water connection was approved (3-0). On a motion by Sterling, seconded by Weimann, the reduction to \$500 per unit for a sewer connection was approved (3-0)
- 5. MS1 Certification was approved as presented on a motion by Sterling, seconded by Weimann, (3-0).
- 6. October 23<sup>rd</sup> BOS Meeting was proposed to be rescheduled to October 30<sup>th</sup>. On a motion by Weimann, seconded by Sterling was approved (3-0). Notices with the change will be posted.
- 7. Budget Direction The Budcom will be meeting on Wednesday 10/11 and will need BOS guidance for budget direction. The Police and DPW contracts increased by 2%. The BOS asked that department heads to look for ways to save money, use resources and be cost conscious.
- 8. Mike Pimental Right of Way Request- The BOS is open to discuss this matter with Mr. Pimental. They requested that the property be flagged to indicate where he wants the Right of Way and that Town Staff look at the property. A proposal with restrictions; insurance and maintenance requirements would then be made and Mr. Pimental would meet with the BOS to discuss it.
- 9. Resolution #2017-38 Acceptance of Grants from Game Time and Authorize Use of Matching Funds from the Recreation Revolving Fund. Recreation Director Sangermano provided renderings of Phase 1 and Phase 2 of the playground structures. The total cost of the playground would be \$53,500, with 60% funding from the Game Time grant,

leaving a balance due of \$34,701.55. This would not have any tax impact as the funds being used are raised by the Recreation Department program user fees.

She is planning additional fundraising for phase 2 and will seek additional grant funding. After discussion of the total cost and grant money available, On a motion by Sterling, seconded by Weimann, he BOS accepted the Game Time Grant of \$18,453.20 and using \$34,701.55 out of the Recreation Revolving Fund was approved (3-0)

10. <u>Resolution #2017-39</u> – Retirement Recognition – Erlene Brayall - On a motion by Sterling, seconded by Weimann, Resolution #2017-39 was approved (3-0).
