- Cable Franchise Agreement Update The agreement expires in July 2020. TM Frederick will work with Jo Anne Carr to see if FIOS can get out to outer Jaffrey, so all of the town is covered. Rindge did a municipal bond extending coverage to the entire town, which will be paid for by the subscribers. Chairman Sterling commented that if there was enough demand, we could talk with the existing carrier to do a similar bond.
- o <u>Light Pole Removal at Humiston Field</u>- 9 Light poles are rotten near the baseball field and will be removed. The poles date back to 1977.
- O Drinking Water Meeting- There was a meeting in Concord today. Jaffrey and Peterborough presented again today, and the vote was to approve as a Special Project, which met funding approval. Once funding is in place, then we can approach them for the State to support Millipore and the project. Northern Borders has announced funding options and we will be applying for that grant as well.
- Town Meeting/Elections Elections are tomorrow and the FPU Football team will be present
 with golf carts to escort residents to the building from the parking lot. Town Meeting is
 scheduled for Saturday 3/14 at 9am at Pratt Auditorium.
