## 1989 TOWN MEETING WARRANT

To: The inhabitants of the Town of Jaffrey, in the County of Cheshire, in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Ernest J. Pratt Auditorium in said Jaffrey on Tuesday, the 14th of March next, at nine o'clock in the forenoon (polls close at 7:00 pm) to vote for the Town Officers and to act on other questions required by law to be decided by official ballot. Pursuant to RSA 39:2a and the vote of the Town at adjourned session of Town Meeting on March 15th, 1979, the business meeting will be recessed until ten o'clock in the forenoon, Saturday March 18, 1989, at which time the Town will act on all subjects described in the following Warrant Articles except those requiring action by Official Ballot:

Art. 1. To choose the following Town Officers: (By Official Ballot)

Chief Engineer of the Fire Department for 1 year - Donald K. Sawtelle
Tax Collector for 1 year - Dawn L. Oswalt
Treasurer for 1 year - Francis R. Chamberlain
Selectmen for 3 years - Jeanne L. LaBrie
Trustee of the Trust Funds for 1 year - Robert K. Massey
Library Trustee for 1 year - Jean B. Page
Library Trustee for 2 years - Francis X. Cheney
Library Trustee for 2 years - Charles H. Griswold
Library Trustee for 3 years - Elizabeth B. Shea
Library Trustee for 3 years - John J. Stone

Recessed until March 18, 1989 at 10:00 a.m. The hour of 10:00 a.m. having arrived , the town moderator Bernard J. Hampsey, Jr. reconvened the annual town meeting of the Town of Jaffrey. The Pledge of Allegiance was said and an invocation was given by Reverend Nelson Howard, III.

The Moderator then ruled that the following procedure would be implemented from this meeting on: Petitions for secret yes/no ballots would only be accepted during the course of or after the discussion on the article itself and petitioners must be five or more voters present at the meeting.

The following resolutions and awards were presented by Selectman Franklin W. Sterling,  ${\rm Jr.:}$ 

"Honoring George A. Sirois, who died March 11, 1989, for his 22 years as the Town's Water Commissioner. This resolution is for George Sirois who was born in Jaffrey, graduated from Conant High and worked at DD Bean for 28 years and at Millipore for 16. He generously volunteered his free time to our Town, in the Jaffrey Fire Department, and to the State, as deputy fire warden. George was also a member of the Jaffrey Lions. Whereas George Sirois has served the Town of Jaffrey as the Town's water commissioner from 1965 to 1987; be it resolved that the most sincere gratitude of the Town be expressed at records of this meeting."

Art. 26. To see if the Town of Jaffrey will vote to raise and appropriate the sum of Four Thousand Seven Hundred and Fifty Dollars (\$4,750.00) for Monadnock Family Services, or take any other action relating thereto. (By Petition) Recommended by Budget Committee

Joe Manning moved the question.

Article was passed by voice vote.

Art. 27. To see if the town will vote to instruct the Town's Representatives to the General Court to respond to our solid waste crisis by taking all necessary measures to insure that New Hampshire adopt legislation that will permit consumers to return for refund of deposit within New Hampshire all soda, beer, wine cooler and liquor containers and that all unclaimed deposit monies shall be collected by the State and no less than 80% shall be returned annually to local municipalities for the sole purpose of implementing, expanding and reimbursing community recycling projects. (By Petition)

David Jacke moved the question.

Richard Grodin motioned to amend and replace the article as follows: "The people of Jaffrey, in town meeting assembled, hereby communicate to its representatives of the General Court that Jaffrey endorses the early enactment of legislation aimed at successful management of the State's solid waste problem, that such legislation include provisions for waste reduction including recycling, redeemable containers, and state level financial support to local waste management."

The amendment passed by voice vote and was voted upon.

Article was passed by voice vote, as amended.

Art. 28. To see if the Town will vote to establish a mandatory recycling program to become effective no later than September 1, 1989 and to authorize the Board of Selectmen to adopt an ordinance establishing a recycling program in accordance with RSA's 31:39, 147 and 149:13. (By Selectmen)
