Variance – The applicant requests a variance to replace an existing culvert (Land Use Code, Zoning Ordinance Section XX, 20.5.2)

Paula Geraghty, 580 Mountain Rd, LLC has retained Attorney Ariane Ice to represent her as they move forward with their variance request. On March 2, 2023 Attorney Ice submitted the following letter requesting to withdraw ZBA 22-23.

I am writing on behalf of 580 Mountain Rd., LLC and their application for a variance. The hearing was continued to April 4, 2023 to allow NHDES to take action on a pending permit application. The estimate from our engineer-and NHDES itself-is that a final determination from NHDES could take a few months. In the interest of efficiency for all involved I am withdrawing the pending variance application and will resubmit a new application as soon as NHDES approves or denies the permit request.

I have spoken to counsel for the town and the town's CEO who has no objection to holding the hearing after we have news from the state. My clients are continuing to work in good faith to resolve all pending issues with the town at this time.

  going to Superior Court. Superior court does not specialize in land use or housing law.
