1. ZBA 19-12, Belletetes, Inc., Owner, 51 Peterborough St. Map 238 / Lot 284.1 Zone: Gen Business (with town water & sewer)

Variance – The applicant requests a variance to add fill within the wetland conservation district. (Land Use Code, Zoning Ordinance Section XX, 20.4)

Variance – The applicant requests a variance to add impervious cover within the wetland conservation district. (Land Use Code, Zoning Ordinance Section XX, 20.7)

Presentation: Jack Belletete

Mr. Belletete presented a revised site plan reflecting a change of location for the truck entrance. This adjustment would move the entrance from the NW side to the SE side of the building, further away from Randy Cournoyer's property, map 238 lot 243. Trucks would enter straight into building from the Peterborough Street side. The previous plan required trucks to perform a 3-point turn to enter/exit the building. This change should reduce the noise. The total amount of impervious surface would not increase, just be relocated.

Justin Grandy, abutter, is in favor of the change if it makes the site quieter.

Elizabeth Webster, ConCom has no objection to the proposal.
